



ORDER

Administrative approval and financial sanction was accorded for the scheme 'Electrical works for setting up of Mother & Child Hub at Jalpaiguri District Hospital of Jalpaiguri District' at an approved cost of Rs. 316.82 Lakh (Rupees Three Crore Sixteen Lakh & Eighty Two Thousand) only vide order no. HFW/NRHM-91/2013/(2990)/2996 Dated. 27.09.2017. The work was awarded to West Bengal Medical Service Corporation Limited for execution through Executive Engineer, PWD, Jalpaiguri Electrical Division.

2. Now, Managing Director, WBMSCL has informed this end that an amount of Rs. 77,23,231.00 only had been put to tender in excess of the sanctioned amount of Rs. 3,16,82,000.00 (Rupees Three Crore Sixteen Lakh Eighty Two Thousand). The total value of the scheme has therefore enhanced by Rs. 78,50,023.00 only. Hence, in continuation of the abovementioned order no. additional administrative approval & financial sanction is hereby accorded for the scheme 'Additional electrical works for setting up of Mother & Child Hub at Jalpaiguri District Hospital of Jalpaiguri District' at an approved estimated cost of Rs. 78,50,023.00 (Rupees Seventy Eight Lakh Fifty Thousand & Twenty Three) only.

3. The work will be executed by the Executive Engineer, PWD, Jalpaiguri Electrical Division & ex-officio Executive Engineer, West Bengal Medical Service Corporation Limited.

4. Fund will be released after submission of requisition of fund from the end of West Bengal Medical Service Corporation Limited in due course.

5. Senior Accounts Officer, National Health Mission will be act as drawing and disbursing officer for the said purpose after submission of requisition of fund from WBMSCL.
