Among 4 technically disqualified bidders, 2 bidders were rejected as one of the bidders had submitted the bid through a distributor in spite of having registered office in India, the 2 <sup>nd</sup> bidder has not agreed to the delivery schedule as per the bid document and 2 other bidders have submitted conditional bids to supply against LC only During onsite physical inspection only 1 equipment corroborated and rest 3 equipments did not corroborate with the technical specification of the bid document. Less than 3 technically qualified bidder <b>Schedule IV:</b> 3 bidders had submitted bids. All 3 bids were conditional. The bidders have agreed to supply only against LC. <b>Schedule V:</b> Bids were not opened. The schedule was cancelled and retendered (vide no. WBMSCL/NIT-09/2013, dated- 26.02.2013) due to submission of less than 3 bids.
