- 3. Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.
- 4. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 5. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 6. Buyer Added text based ATC clauses
 - 1. Bidders should arrange for an onsite functional demonstration of the offered equipment on the noti fied date at any facility at Kolkata, West Bengal or at **Swasthya Bhavan**. The evaluation of the spec indi cator will be made based on the reports of the onsite functional demonstration of the equipment. The ons ite functional demonstration of the equipment is purely at the discretion of the Technical Bid Evaluation C ommittee and its input shall be treated as only corroborative in nature and will not be a substitute for technical evaluation of the document submitted along with the bid. The decision of the Technical Committee in this regard will be final.

Bidder has to comply with all parameters of the technical specifications except deviation(s) which will be considered minor and acceptable by the team of Experts to be engaged by WBMSCL to take working / fun ctional demonstration of the offered equipment.

- **6.** Availability of Service Centers : OEM / Bidder must have a Functional and operational Service C entre in **Kolkata**, and have capability of providing service as and when required.
- **7.** Successful bidder/OEM will have to ensure that adequate number of dedicated technical service pers onals / engineers are designated / deployed for attending the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period.
- **8.** End user training must be provided within the warranty period without any charges as many as num bers required.
- 9. Restrictions under Rule 144(xi) of the general Financial Rules(GFRs),2017:As per offic e memorandum from the Ministry of Finance, Govt. of India the following clause will be effective from dated- 08.02.2021 where has been clearly mentioned that, "in case a bidder has pro posed to supply finished goods procured directly/indirectly from the vendors from the countries sharin g land border with India, such vendor will be required to be registered with the competent Authority."

- **20.** The equipment should be USFDA & European CE (4 digit European notified body) certified. The Quoted model name & make should be mentioned in the certificate.

- a) The equipment including all other accessories, ancillaries and whole turnkey work as given in the sp ecifications of the equipment including UPS, UPS Battery, AC machines and furniture etc.
- b) Bidders must enter in to the CMC with WBMSCL directly / third party as authorized by H&FW Dept/WBMSCL etc. Bidder must accept the same CMC rate, if the CMC is offered by the third party/WBMSCL the n no escalation, no extra cost will be provided. - 16. Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.
- 17. Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imberse the cost of such service / rectification to the Buyer.
- 18. The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.
- 19. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if
 - i) The Seller fails to comply with any material term of the Contract.
 - ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

 - iv) The Seller becomes bankrupt or goes into liquidation.

- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
