Procurement & supply of consumable, accessories and plastic ware for COVID-19 testing purpose

West Bengal Medical Services Corporation Limited (WBMSCL) has been requested by the Government of West Bengal to procure on their behalf **consumable**, **accessories and plastic ware** to be supplied to different COVID 19 testing laboratories of the State of West Bengal. WBMSCL hereby invites e-bids from eligible and qualified Tenderers for **fixation of rate** for supply of **consumable**, **accessories and plastic ware required for COVID 19 testing** in accordance with the procedure elaborated below and subject to the broad terms and conditions mentioned:

Intending Tenderer may download the tender document from the e-tender portal of Govt. of West Bengal at wbtenders.gov.in and the website of WBMSCL at www.wbmsc.gov.in. The submission of bids should be through online at wbtenders.gov.in. Earnest money should be submitted in favour of 'West Bengal Medical Services Corporation Limited' online only through www.wbmsc.gov.in.

- Any bonafide agencies having registered office in India, manufacturing / operational unit in West Bengal can participate.
- b) The agency should have turnover of Rs.1 Crore (Rupees One Crore) for the 03 (three) financial years (2019-2020, 2020-21 & 2021-22) would be allowed to participate in the process.
- c) Earnest money deposit (EMD): Bidders to submit EMD online of amount Rs. 50.000/-
- d) The item wise list of consumable along with specification proposed to be procured & supplied to the laboratories are mention in **Annexure A**. The bidders are to quote rates in the designated cells. Selection of bidder will be based on the quoted rate for the items.
- e) The bidders would have to submit listed documents including inter alia, their contact details, annual turnover, and credential of Government supply in India in the format provided at Annexure B.
- f) Any manufacturer/its subsidiary which is currently black-listed by any Government Department / Agency in India would not be eligible to participate in the tender.

g) Restrictions under Rule 144(xi) of the general Financial Rules (GFRs), 2017: As per office memorandum from the Ministry of Finance, Govt. of India the following clause will be effective from dated- 08.02.2021 where has been clearly mentioned that, "in case a bidder has proposed to supply finished goods procured directly/indirectly from the vendors from the countries sharing land border with India, such vendor will be required to be registered with the competent Authority."

h) Preference for S.S.I. units registered in West Bengal & PSUs in West Bengal:

Preference will be given to the S.S.I. units registered in West Bengal & PSUs in West Bengal and State Based Other Manufacturers as per West Bengal Financial Rule incorporated under notification No. 10500-F dated 19.11.04 as amended hereafter.

Exemption from payment of earnest money for tenders, payment of security deposits, if selected and price preference for S.S.I. units registered in West Bengal & PSUs in West Bengal will be given as per West Bengal Financial Rule incorporated under Finance Department notification No. 10500-F, dated 19.11.2004 read with its amendments.

Bidders should upload valid registration certificate / document issued by Government authority in support, if aforesaid exemption has been applied for. Any bid without EMD is liable to be cancelled, if requisite document in support of availing such exemption(s) is not submitted.

- i) Intending Tenderer may download the tender document from the website of WBMSCL namely www.wbmsc.gov.in and the website of Health and Family Welfare at wbhealth.gov.in. The submission of bids should be online on wbtenders.gov.in only.
- j) The intending bidders will thereafter have to quote rates for the items for which they have participated in the tender and upload the **BoQ** under Financial Bid (Bid F).

- m) The technical bid of the bidders will be opened and evaluated first. The shortlisted or the qualified bidders, primarily on the basis of the above mentioned objective. The list of qualified bidders would duly be published in https://wbtenders.gov.in for the second stage of the tender process. After opening of financial bids, the lowest among the bidders against the items would generally be awarded the contract, after observance of the related formalities.
- n) If L1 bidder(s) fails to supply within the timeline of the tender or misquote the selected brand of the item Tender Inviting Authority (TIA) may opt for L1 rate matching with L2, L3, L4.....bidders subsequently for the remaining required quantity.
- o) The decision of the TIA in the matter would be final and binding upon all participants in the tender, and the tender inviting authority would have the absolute discretion to reject or accept bid of any bidder, without assigning any reason whatsoever.
- p) WBMSCL would be at liberty to procure such items in as many tranches as may be considered expedient, in the interest of public service or may communicate the accepted rates to the Laboratories undertaking COVID 19 testing for procurement as per their need.
- q) WBMSCL reserves the right to increase the quantity of 40% (Forty percent) or above in case of need / or to decrease the quantity of goods and related services by 40% (Forty percent) originally specified in the tender document, and without any change in the unit prices or other terms and conditions of the Bid Documents.
- r) The rate offered in the financial bid should remain valid for a period of 2 (Two) year from the date of opening of Financial bid.
- s) **Payment Terms:** Payment will be released within 30 days on receipt of invoice completed in all respect and on production of Consignee Receipt Certificate (CRC) duly signed by the consignee after completion of delivery at the consignee locations.
- t) **Performance Security (PS):** 10% of the Bid Value (Validity should be 6 (Six) months within 14 days of receipt of the AOC from WBMSCL.

u) Selected Agencies will have to supply 50% of the items within 7 days after issuance of AOC and remaining quantity must be supplied in next 14 days as staggered manner, if required.
