6	Issuance of Materials	The total work will have to be completed by the vendor at his own risk, tools and tackles and cost including cost of transportation of goods, wall cutting, & labour charges etc. Authorized Representative of WBMSCL at site will verify and certify the work.

BOQ & TECHNICAL SPECIFICATIONS

All parameters mentioned in the BOQ are Essential. Bidder has to comply with all Essential parameters of the BOQ except deviation(s) which will be considered minor and if acceptable by the team of experts to be engaged by WBMSCL.

Documents comprising the Tender: (Bidders are instructed to submit their tender consisting of sealed envelope.)

Bidder shall comprise the following documents for qualifying the tender: -

- (a) PAN Card.
- (b) GST Reg. Certificate.
- (c) Credential of Rs. 1,91,200/- in similar nature of works for the last 3(three) financial years under any govt./semi govt./corporation/statutory/govt. undertaking/Private organization.
- (d) Tender must be submitted along with all the relevant documents. This is required to show that the bidder had accepted all the terms and conditions mentioned in this NIT document.
- (e) Rate of must be quoted in figure as well with standard comprehensive manufacturer's warranty (if any) and 1(one) year DLP period by the contractor.

Period of Validity of quoted rates:

Quoted Rate shall remain valid for a period of 365 days after the tender submission deadline date prescribed by WBMSCL. A tender valid for a shorter period shall be rejected by WBMSCL as non responsive.

In exceptional circumstances, prior to the expiration of the tender validity period, WBMSCL may request Bidders to extend the period of validity of their tender. The request and the responses shall be made in writing. A Bidder granting the request shall not be required or permitted to modify the tender.

Submission, Sealing and Marking of tenders:

Bidders may always submit their Tender by hand. Bidders will submit the tender sealed in envelope which shall:

- (c) If the envelope/s is not sealed and marked as required, WBMSCL will assume no responsibility for the misplacement or premature opening of the Tender.

Deadline for Submission of Tenders

- (a) Tender must be submitted by the Bidder at WBMSCL, Swasthya Sathi Building, GN-29, Salt Lake, Sector-V, Kolkata-91 latest by 14:00 hours on 17/03/2020.
- (b) WBMSCL may, at its discretion, extend the deadline for the submission of Tender by amending the Bidding Documents, if felt necessary.


- (c) WBMSCL shall not consider any Tender that arrives after the deadline for submission of Tenders, or that which has not been received at the stated address within the deadline of submission for Tender. Any Tender received by WBMSCL after the deadline for submission of Tenders shall be declared late and straight way rejected.

Tender Opening

- (a) WBMSCL or its duly authorized representative or committee will open the Tender in the presence of intending bidders who may be present at the time of Opening.
- (b) A Tender will be considered as non responsive and will be rejected/ cancelled under the following conditions:
- Does not have any of the documents as mentioned in the NIT.
 - Does not have the required technical eligibility as per documents submitted by the Bidder.
 - If the bidder submits conditional Tender.
 - Submits incomplete Tender as per price format.
 - The Bidder does not accept important Contract conditions.
- (c) Tender will be opened and as well as accepted only in case of those Bidders who have submitted the all other documents mentioned in the NIT. On opening the Tender the Committee will enter the amounts in a Comparative Statement Form.

Terms and Conditions


01. Percentage Rate quoted should be above/at per/below of the rate mentioned in the BOQ (Annexure-A & B) by the bidders. The BOQ rate as shown in the Annexure-A & B inclusive of all charges i.e. GST, Delivery charges etc.
02. Each Bidder shall submit only one Tender.
03. WBMSCL will evaluate the tender documents and will make it responsive considering properly signed tender documents, complying the terms, conditions and specifications as asked in the NIT.
04. WBMSCL reserves the right to accept or reject any Tenders and to cancel the bidding process and reject all Tenders, and does not bind to accept the lowest rate.
05. The Bidder whose tender is accepted will be notified. The work order/AOC will be offered in due course by WBMSCL along with relevant terms of acceptance.
06. The rate accepted by the WBMSCL will remain valid for 365 days from the date of issue of the work order and the awarded agency may be allowed to undertake the similar work under WBMSCL at different SSHs at the same rate and other terms condition unaltered.
07. Payment shall be made within 30(thirty) days after successfully completion of the above mentioned work on submission of supportive documents & bills to WBMSCL duly checked and signed by the site in-charge of the said work.
