## Amendment – VI

Read Clause 35 (marked in red below) at Page No. 13: Submission and Opening of Bids

**iii) BID – C [Bill of Quantity (BOQ), the Statement of Breakup of Duties and Taxes and Cost of Consumables & Spares]**

BOQ shall contain the financial quotes in respect of (a) **Gross Price of Equipment (b) Comprehensive Maintenance Contract (CMC) charges.**

- (a) **Gross Price of Equipment (GP):** includes value of goods, accessories & ancillaries and taxes, duties, freight charges, insurance, installation, commissioning, end user training as many number of times as required during the period of warranty and any other charges as applicable. **Entry tax @ 1% should also be considered in the Gross Price.**

**iii) BID – C [Bill of Quantity (BOQ), the Statement of Breakup of Duties and Taxes and Cost of Consumables & Spares]**

BOQ shall contain the financial quotes in respect of (a) **Basic Price of Equipment (b) Comprehensive Maintenance Contract (CMC) charges.**

- (b) **Basic Price of Equipment (BP):** Basic Price of Equipment(s) includes value of goods, warranty for 2 years, accessories & ancillaries, other charges (e.g. freight charges upto the consignee location, insurance etc), installation , commissioning , end user training as many numbers as may be required during the period of warranty but excluding applicable tax (es).

## Amendment – VII

Read Clause 15 (marked in red below) at Page No. 23: Section II. General Conditions of Contract

1. **BLACKLISTING:**

Any bidder / tenderer or its manufacturing agency currently blacklisted by any Government agency in India, is not eligible to participate.

15. BLACKLISTING:

Any manufacturer / its subsidiary which has been blacklisted by any Government Department/ Agency in India during the last five years, would not be eligible to participate in the tender.
