5. (b) Payment Terms

Those who are interested to Quote the item in Letter of Credit(LC)

Payment for Main Equipment & Domestic Goods: Irrevocable and non – transferable 100% LC shall be opened, however, if the Supplier requests specifically to open confirmed LC, the additional charges, if any would be borne by the Supplier. If LC is required to be extended and/or amended for reasons not attributable to the Purchaser/Consignee, the additional charges thereof shall be borne by the Supplier. Applicable custom duty and custom clearance charges will be borne by the supplier.

Terms and Mode of Payment

Payment Terms

A) Payment for Main Equipment & Domestic Goods:

Quotes against Main Equipment & Domestic Goods shall be made in Indian Rupee (INR) as specified in the Contract in the following manner:

a) On Shipment:

75% payment of the unit price for Payment for Main Equipment & Domestic Goods will be released against furnishing of of Consignee Receipt Certificate (CRC) as per **Format 3a** and against submission of Performance Bank Guarantee of 10% of the order value valid for a period of 26 (Twenty Six) months.

The bidders shall submit the documents specified hereunder:

- (i) Four copies of Supplier's invoice showing contract number, goods description, quantity, unit price and total amount;
- (ii) Original and four copies of the lorry receipt;
- (iii) Four copies of packing list identifying contents of each package;
- (iv) Insurance Certificate
- (v) Certificate of country of origin.
- (vi) Consignee Receipt Certificate (CRC) as per Format 3a

Bidders may note that the selected bidder should submit the Performance Bank Guarantee within 14 days after issue of Award of Contract. A Contract will be signed thereafter followed by opening of LC.

b) After Supply and Installation & Commissioning

Remaining 25% payment of the unit price will be released after 2 (two) months supply and successful installation, commissioning and initial end user training by the authorized service team of the supplier of Satisfactory Installation Certificate (SIC) issued by the user Department of the consignee. Formats of SIC is uploaded in the NIT Document. SIC will be signed by the facility / end user or issued after joint certification by authorised official(s) from WBMSCL and the facility/ end user.

<u>Those who are interested to Quote the item in Non Letter of</u> <u>Credit</u>

I. General Terms

- (i) The payment to manufacturing company or its subsidiary in India will be made under Delivered Duty Paid contract.
- (ii) The Tenderers should only quote in INR.

II. Payment terms for Manufacturer/Indian Distributor

- A. 75 % of the Base Price of the Equipment along with applicable GST shall be paid after delivery and furnishing of Consignee Receipt Certificate (CRC) as per **Format 3a**.
- B. Remaining 25% of the Base Price of the Equipment along with applicable GST shall be paid after 2 (two) months of successful installation, commissioning and initial end user training by the authorised service team of the supplier and furnishing of Satisfactory

Installation Certificate (SIC) as per **Format 3b**. The SIC shall be signed by the facility / end user or issued after joint certification by authorised official(s) from WBMSCL and the facility/ end user.

Note:Submission of required Performance Bank Guarantee and signing of Agreement are mandatory for the processing of any Payment.

Base Price of Equipment(s) includes value of goods, accessories & ancillaries, freight charges, installation, commissioning, end user training as many number of times as required during the period of warranty and any other charges as applicable excluding GST. Applicable GST will be paid extra.
