Period of Validity of Bids:

Quoted Rate shall remain valid for a period of 3(three) years after the bid submission deadline date prescribed by WBMSCL.

In exceptional circumstances, prior to the expiration of the bid validity period, WBMSCL may request Bidders to extend the period of validity of their bids. The request and the responses shall be made in writing. In such case the Bid Security shall also be extended for a corresponding period. A Bidder may refuse the request without forfeiting its Bid Security. A Bidder granting the request shall not be required or permitted to modify the bid.

Submission, Sealing and Marking of Bids:

Bidders may always submit their Tenders by hand. Bidders will submit the Tender in sealed envelope.:

(c) If the envelope/s is not sealed and marked as required, WBMSCL will assume no responsibility for the misplacement or premature opening of the TENDER.

Deadline for Submission of Bids:

- (a) TENDER must be submitted by the Bidder at WBMSCL, Swasthya Sathi Building, GN-29, Salt Lake, Sector-V, Kolkata-91 latest by 14:00 hours on 14/11/2018.
- (b) WBMSCL may, at its discretion, extend the deadline for the submission of TENDER by amending the Bidding Documents, if felt necessary.
- (c) WBMSCL shall not consider any TENDER that arrives after the deadline for submission of TENDER s, or that which has not been received at the stated address within the deadline of

submission for TENDER. Any TENDER received by WBMSCL after the deadline for submission of TENDER shall be declared late, rejected.

Bid Opening:

- (a) WBMSCL or its duly authorized representative or committee will open the TENDER in the presence of intending bidders who may be present at the time of Opening.
- (b) A TENDER will be considered as non responsive and will be rejected/ cancelled under the following conditions:
 - · Does not have any of the documents as mentioned in the NIT.
 - · Does not have the required technical eligibility as per documents submitted by the Bidder.
 - · If the bidder submits conditional bid.
 - · Submits incomplete TENDER as per price format.
 - · The Bidder does not accept important Contract conditions.
- (c) TENDER will be opened and as well as accepted only in case of those Bidders who have submitted the all other documents mentioned in the NIT. On opening the TENDER the Committee will enter the amounts in a Comparative Statement Form.

Liquidated Damages:

If the Contractor fails to complete the Works within the time of completion which is 60(sixty) days from the date of issuing of work order, the Corporation shall, without prejudice to other rights and remedies available to the Corporation under the Contract, deduct from the deposited EMD amount, as Liquidated Damages, a sum equivalent to 0.5% per week of delay or part thereof until the date of successful completion of the Works to the satisfaction of Engineer-in-Charge, subject to a maximum of total EMD amount. Once the maximum delay has been committed by the Contractor, the Corporation may proceed for termination of the Contract, in accordance with the STC without prejudice to the Corporation's right to terminate the Contract even prior thereto for breach by the Contractor. No Liquidated Damages shall be imposed on the Contractor by the Corporation, without giving a reasonable opportunity to the Contractor to explain the reason behind its delay.

Terms of Payment:

In case of providing new Fire & Life Safety Certificate 30% of the quoted amount for the aforesaid work may be released by WBMSCL only after production of FSR(Fire Safety Recommendation) to WBMSCL after necessary formalities and relevant task in this regard with fire department and other establishment as and when required. Balance payment may be released on successful production of NOC certificate as desired by WBMSCL.

In case of only renewal of Fire & Life Safety Certificate, no part payment will be allowed and the agency will be allowed to get full payment in respect of the said renewal after production of renewed NOC certificate to WBMSCL.

General Terms and Conditions

- 01. Quoted Rate must be inclusive of all charges i.e. GST, Excise Duty, Supply & Delivery at the above mentioned SSHs, etc.
- 02. The Rate should be quoted in Indian Rupee only.
- 03. No interest will be payable against Security Deposit.
- 04. WBMSCL will evaluate and compare the TENDER determined to be substantially responsive i.e.which
 - (a) Are properly signed.
 - (b) Conform to the terms and conditions, and specifications.
- 05. WBMSCL reserves the right to accept or reject any TENDER s and to cancel the bidding process and reject all TENDER s, and does not bind to accept the lowest rate.

- 06. The work order will be issued to the lowest bidder incorporating the detail schedule of work.
- 07. Payment shall be made within 30(thirty) days after successfully completion of the above mentioned work against submission of supportive documents, Test certificates, challan & bills duly certified by the site in-charge of the respective sites.

- 09. If the Bidder withdraws and change the quoted rate during this bid validity period, WBMSCL will take strict action against it and terminate the company/agency for a long period and this feedback on the Vendor's performance would be taken as an input for the future project by WBMSCL.
