West Bengal Medical Services Corporation Limited (WBMSCL) has been requested by the Government of West Bengal to procure 10,000 units of **Finger Tip Pulse Oximeter** on their behalf for COVID 19 purpose. WBMSCL hereby invites bids from eligible and qualified Tenderers for supply of **Finger Tip Pulse Oximeter** required for COVID 19 purpose in accordance with the procedure elaborated below and subject to the broad terms and conditions mentioned:

Intending Tenderer may download the tender document from [www.wbmsc.gov.in](http://www.wbmsc.gov.in) and [wbhealth.gov.in](http://wbhealth.gov.in). The submission of bids should be through offline in sealed envelope at WBMSCL office. Earnest money to be drawn in favour of 'West Bengal Medical Services Corporation Limited' through Demand Draft issued from any scheduled bank payable at Kolkata.

- a) Any bonafide agencies having registered office in India, manufacturing / operational unit in West Bengal can participate.
- b) The agency should have average annual turnover of at least Rs.1 crore for the two financial years (2017-18, 2018-19) would be allowed to participate in the process.
- c) Earnest money deposit (EMD): Bidders to submit EMD of amount Rs. 1,00,000/- in the form of Demand Draft (DD)
- d) The specification is mention in **Annexure A**. Selection of bidder will be based on the quoted rate for the item.
- e) The bidders would have to submit compliance sheet in the format provided at **Annexure B**.
- f) The bidders would have to submit listed documents including inter alia, their contact details, annual turnover, credential of government supply in India in the format provided at **Annexure C**.
- g) Any manufacturer / its subsidiary which is currently black-listed by any Government Department / Agency in India would not be eligible to participate in the tender.
- h) Intending Tenderer may download the tender document from the website of WBMSCL namely [www.wbmsc.gov.in](http://www.wbmsc.gov.in) and the website of Health and Family Welfare at [wbhealth.gov.in](http://wbhealth.gov.in). The submission of bids should be offline in sealed envelope.

- i) **Delivery Timeline:** Total supply to be completed within 7 days in 3 tranches as per following schedule

- k) The technical bid of the bidders will be opened and evaluated first. The shortlisted or the qualified bidders, primarily on the basis of the above mentioned objective. The list of qualified bidders would duly be published in [wbmsc.gov.in](http://wbmsc.gov.in) for the second stage of the tender process. After opening of financial bids, the lowest among the bidders against the items would generally be awarded the contract, after observance of the related formalities.
- l) If L1 bidder(s) fails to supply the selected item within the timeline of the tender, Tender Inviting Authority (TIA) may opt for L1 rate matching with L2, L3, L4.....bidders subsequently for the remaining required quantity.
- m) The tender inviting and accepting authority can vary quantity up to 40% (forty percent) above or 40% (forty percent) below the required quantity under this tender
- n) The decision of the TIA in the matter would be final and binding upon all participants in the tender, and the tender inviting authority would have the absolute discretion to reject or accept bid of any bidder, without assigning any reason whatsoever.
- o) The rate offered in the financial bid should remain valid for a period of 12 (twelve) months from the date of issue of Award of Contract (AOC), but may be extended on mutual agreement.
- p) **Payment Terms:** Payment will be released within 15 days on receipt of invoice completed in all respect and on production of Consignee Receipt Certificate (CRC) duly signed by the consignee after completion of delivery at the consignee locations.
- q) **Performance Security (PS):** Rs. 5,00,000 (Rupees Five Lakh) in the form of DD / BG of Validity 14 months within 14 days of receipt of the 1<sup>st</sup> AOC from WBMSCL.

Interested bonafide agencies are therefore invited to submit the relevant documents offline in sealed envelope to WBMSCL Office within the specified date mentioned in the NIT.
