- 3. Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the marl and has at least 2 years residual market life i.e. the offered product shall not be declared end-of-life by the Ol before this period.
- 4. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
