13. WBMSCL's right to vary quantities:

WBMSCL reserves the right to increase the quantity (in case of need) of goods and related se rvices and without any change in the unit prices or other terms and conditions of the Bid Do cuments.

17. Cost of Bidding

The Tenderer shall bear all cost associated with the preparation and submission of its bid.

18. Language of Bid

The Bid, as well as all correspondence and documents relating to the bid exchanged by the Tende rer and WBMSCL, shall be written in the English language. Supporting documents and printed liter ature that are part of the Bid, if submitted in any other language provided they are accompanied by an accurate translation of the relevant passages into English and duly authenticated.

- 19. Prices quoted by the Tenderer shall be fixed during the Tenderer's performance of the Contract and not subject to variation on any account.
- 20. The objective of this bid is to ensure supply of best quality equipment at the most competiti ve price. If at any stage of the bidding, including at the stage of financial evaluation, it appears that the tendered rate is artificially hiked or is much lower compared to the prevailing market

price and available rates of similar or identical composition with the government, WBMSCL res erves the right to cancel the bids.

21. Confidentiality

- Any effort by a Tenderer to influence WBMSCL in the examination, evaluation, comparison of the bids or contract award decisions may result in the rejection of its Bid.
- Notwithstanding Instructions to Tenderers from the time of bid opening to the time of Cont ract Award, if any Tenderer wishes to contact WBMSCL on any matter related to the bidding process, it should do so in writing.
- 22. THE DECISION OF THE WBMSCL AUTHORITY WILL BE FINAL AND BINDING IN THIS MATTER.

a) Responsiveness of Bids

- WBMSCL's determination of a bid's responsiveness is to be based on the contents of the bid i tself.
- A substantially responsive Bid is one that conforms to all the terms, conditions and specificat ions of the Bidding Documents without material deviation, reservation, or omission. A material deviation, reservation, or omission is one that:
- i. Affects in any substantial way the scope, quality, or performance of the goods and rel ated services specified in the Contract;

or

ii. Limits in any substantial way, inconsistent with the Bidding Documents, WBMSCL's rights or the Tenderer's obligations under the Contract;

or

iii. If rectified would unfairly affect the competitive position of other Tenderers presenting substantially responsive bids.

b) WBMSCL considers material deviation to include but not to be limited to the following situations:

- a. During technical evaluation of bids (verification of formal criteria):
- · Lack of proper bid securities in terms of change in the wording (not consistent with the pres cribed format), amount or validity period.
- · Absence of bid form, change in the wording (not consistent with the prescribed format) or la ck of signature in the key portions of the bid form,
- The Tenderer does not accept important Contract conditions, i.e. related to Performance Sec urity, Warranty, Applicable Law, Delivery Schedule, Payment Terms, Limitation of Liability, etc.
- \cdot Specifications of the item quoted vary in one or more significant respect(s) from the minimu m required Technical Specifications.

23. WBMSCL's Right to Accept Any Bid and to Reject Any or All Bids

WBMSCL reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to Tenderers.

24. Award Criteria

 In the event of a Contract award, WBMSCL shall award the Contract to the Tenderer whose offer has been determined to be the lowest evaluated bid substantially responsive to the Bidding Docu ments, provided further that the Tenderer is determined to be qualified to perform the Contract s atisfactorily.

25. Publication of Award of Contract

WBMSCL shall publish the Award of Contract in GEM portal.
