No. 241 installed at department of Radiotherapy, Medical College Hospital, 88, College Street, Kolkata – 700073** to be supplied to various healthcare establishments of the Govt. of West Bengal.

- The tenderer or his representative may remain present at the time of opening provided they bring with them letters of authority from the corresponding tenderers.
- In case the specified date of tender opening falls on / is subsequently declared a holiday or closed day for the purchaser, the tenders will be opened at the appointed time and place on the next working day.

[1] Complete information should be given indicating among other things, facilities required for installation such as electric power supply, ventilation, ducting, minimum area required for housing the unit along with its control panel and optimum climatic condition for operating the system etc.

The details of the cost for the work should be quoted in Bid C of the tender in the following manner:-

- All inclusive cost for Tele-cobalt source change / replacement in Theratron 780C machine at Medical College Hospital, Kolkata – in BoQ
- Breakup of the cost such as freight, insurance, installation, charges on road permit, transportation upto site of installation, bank charges and any other charges whatsoever may be given in Form - 7;

[2] Earnest Money Deposit of 2,50,000 (Rupees Two Lakh Fifty Thousand Only) must be submitted online in the e-tender portal (wbtenders.gov.in)

[3] The Earnest Money Deposit will be returned to the tenderer if the tender is not accepted. In case the tender is accepted, EMD will be retained till the execution of the contract. No interest will be paid on EMD by WBMSCL.

[4] Successful tenderer will have to enter into a contract for transportation, installation & commissioning of the Radioactive to the hospital as per Scope of work for the tender.

[5] Bank guarantee being 10% of the total value of work towards satisfactory performance and services will have to be submitted by the successful tenderer in the prescribed **Format 5** within 14(fourteen) days from the date of issue of award of contract by WBMSCL. An agreement will be signed after submission of the PBG. The bank guarantee shall remain valid for 1 year and will be released on completion of work in all respect and to the satisfaction of WBMSCL.

[6] **Payment terms will be as follows:**

- Payment for Indian origin items or foreign origin located within India will be made only on receipt of Satisfactory Installation Certificate (SIC). In this connection, the supplier will submit bill along with CRC (Form 3a) & SIC (Form 3b) respectively for payment after completion of work in all respect and to the satisfaction of WBMSCL

[7] The tender documents are non-transferable.

[8] The rate if accepted will remain valid for 1(one) year from the date of acceptance and variation of the rate is not allowed under any circumstances during the period.

[9] The rate should be quoted both in figure and in words.

[10] The successful tenderer shall have to finish the job as specified in all respect within 60 days.

[11] Incomplete tender not in conformity with the terms and conditions as in this tender notice will be rejected outright.

[12] The undersigned reserves the right either to accept or to reject any or all the tenders without assigning any reason thereof and is not bound to accept the lowest tender.

Brief Description of Works

Scope of Work:

- a) The bidder needs to collect new Tele-cobalt source from BRIT on behalf of Medical College Hospital, Kolkata.
- b) All necessary arrangements to be done for safe transportation of such highly radioactive source from BRIT, Mumbai following all AERB protocols and guidelines to the site of Medical College Hospital, Kolkata using AERB approved transport agency and AERB approved chartered Truck.
- c) AERB approved container to be arranged in which new source to be transported from BRIT, Mumbai to Medical College Hospital, Kolkata and unloaded decayed source from Medical College Hospital, Kolkata to BRIT KOTA / or any other AERB approved centre for safe disposal of decayed source. Certificate of approval for such container from AERB needs to submit along with tender documents.
- d) AERB authorization for such source transportation operation in favour of the bidder is essentially required. Certificate of approval from AERB needs to provide along with the tender documents.
- e) AERB approved service engineers should be available under the Bidder for such operation. AERB license in favour of service engineers need to provide. List of AERB approved engineers under the bidder must be submitted.
- f) The bidder should be eligible and supply source replacement kit which includes recommended pneumatic spare parts of the unit which are essentially required during source replacement.
- g) GSM Tracking system following AERB guidelines must be arranged.
- h) Sufficient previous experience for such Cobalt source change operation is essentially required. The bidder is required to specify number of such Tele-cobalt source change operation done by them in last three years, necessary documents to be submitted.
- i) The bidder must have all necessary tools to handle such source loading / unloading operation.
